IF THIS MEETING CAN NOT BE HELD ON MONDAY, MAY 11TH, 2020 A CONTINUATION NOTICE WILL BE PUBLISHED IN DARTMOUTH WEEK. THE NOTICE WILL ALSO BE POSTED ON THE ELECTRONIC SIGN LOCATED IN FRONT OF THE STATION.

Article 1. To elect a Moderator to preside over the Annual District Meetings for the ensuing year.

Article 2. To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions; or take any other action relative thereto: Prudential Committee three (3) at \$1,800.00 each or \$5,400.00; Town Assessors - three (3) at \$200.00 each or \$600.00 and Moderator at \$200.00 - \$100.00 per meeting.

Total Amount \$6,200.00

Article 3. To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions; or take any other action relative thereto: Fire Chief - \$95,101.00 per contract; District Clerk \$2,000.00 and District Treasurer \$10,000.00.

Total Amount \$107,101.00

Article 4. To see if the District will vote to raise and appropriate a sum of money to fund the following General Expense Accounts: Building Account \$31,500.00; General Insurance \$52,500.00; General Fund \$65,000.00; Health Insurance \$15,000.00; and County Retirement Account \$21,455.00.

Total Amount \$185,455.00

Article 5. To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions; or take any other action relative thereto: Deputy Chief \$6,000.00; Full Time Firefighters (2) \$110,359.00; Full Time Firefighters Overtime \$7,500.00; Full Time Firefighters EMT Stipends \$400.00; Full Time Firefighters Uniform Allowance \$2,000.00; Call Firefighters \$40,000.00; Firefighter Details and Station Coverage, Drills and EMT Stipends \$40,000.00.

Total Amount \$206,259.00

Article 6. To see if the District will vote to raise and appropriate a sum of money to fund the following Operational Expense Accounts; or take any other action relative thereto: Chief's Account \$600.00; Fire Alarm/Communications \$5,000.00; Fire Equipment - New \$15,000.00; Fire Equipment – Repairs

and Maintenance \$10,000.00; Fire Gear and Uniforms \$18,000.00; Fire Prevention \$1,000.00; Physicals and Recruitment \$4,000.00, Vehicle Repairs and Maintenance \$25,000.00.

Total Amount \$78,600.00

Article 7. To see if the District will vote to raise and appropriate a sum of money for Debt Owed on the Renovation/Construction Loan. Debt Principal - \$130,000.00; Debt Long Term Interest - \$8,775.00

This is the seventh year of the ten-year station renovation/construction loan.

Total Amount \$138,775.00

Prudential Committee Recommends 3-0-0

Article 8. To see if the District will vote to raise and appropriate the sum of \$40,000.00 for the Reserve Fund.

The Reserve Fund is utilized for extraordinary and unforeseen expenditures. The remaining balance will close out at the end of the fiscal year and convert to free cash.

Total Amount \$40,000.00

Article 9. To see if the District will vote to raise and appropriate the sum of \$50,000.00 for the Stabilization Fund.

The Stabilization Fund can be used for any lawful purpose and requires a 2/3 vote to appropriate from it.
