Water St., N.B. be sent letters requesting that the debris be covered over with dirt, otherwise further dumping would be prohibited.

On 11/25/60 each of the above parties contacted the office and reported they would see the City of New Bedford on this matter and the nuisance would be abated.

Mr. Stevens checked property on 9/7/60 and it was his opinion that a new system must be installed and the present system be for the father house.

On 9/6/60 Mr. James Allain, High Hill Rd., N.D. called the office to report that his sink and toilet was blocked for several days and the landlord will not do a thing about the matter.

On 9/7/60 Mr. Stevens investigated and found nuisance existing. The Clerk was instructed to call the owner on 9/7/60 and request that immediate action be taken. Up to the present time no other complaints have been made to the office.

# Minutes of the Dartmouth Board of Health

12/18/67

The meeting came to order at 7:10 p.m. with all members of the Board present. Mr. Norman Menard and E.Merritt Huckins also present.

All bills approved and signed.

Mr. Fred Dayton, Morton Avenue, N.D. called Mr. E.M. Huckins after last week's Board meeting to ask what transpired about his situation. He was informed that Morton Black had called to ask this Board to reconsider, which had been done by Mr. Huckins, with no change in their decision. Mr. Dayton was informed that if he was in disagreement with our estimate of the seasonable height of ground water that the Board recommends placing a section of perforated orangeburg pipe in the ground and measuring in March and April. Mr. Dayton agreed to place the pipe on Sunday, December 17th. Mr. Huckins went out to Morton Avenue on December 18th to check and the pipe had not been placed ther as yet. This was discussed at tonight's meeting and the Board decided placing the pipe was Mr. Dayton's responsibility. This was just a general discussion.

A sand catcher was installed by the D.P.W. on Rockland Street and Forest Lane, S.D. within 12' of the sewerage system of Russell Perry, whose sewerage system had been installed previous to the sand catcher. The Board instructed the clerk to send a letter to D.P.W. informing them that this is too close.

Mr. & Mrs. Manuel Botelho, 167 Sharp Street and Mrs. Lydia
Botelho, daughter-in-law, met with the Board to discuss the problem
on their property of water entering their cellar, since the vacant
lot next to them is being filled in. Also a shack, Mr. Botelho &eeps
his lawn mower and other tools in, are ruined from water. Rats are prevalent in the area. Mr. Medeiros is filling in the lot for J.F. Martin.
The Board thought a trench toward the wooded area might alleviate the
situation. Later in the evening, Mr. J.F. Martin met with the Board

On 12/5/67 Mr. Joseph Santos reported to the office Mr. Henry Souza, 208 Fisher Rd., N.D. objects to Jose Abreau keeping swine at 218 Fisher Rd., N.D. Mr. Souza said the swine are dirty, there is an odor and the pens are improper.

On 12/11/67 Mr. Abreau informed William Martin he has no intention of keeping swine at the Fisher Road address. Mr. Abreau resides at 296 Hemlock St., N.B.

It was a majority vote of the Board to send Mr. David Lassister, 594 Division Road, N.D. a letter to vacate his trailer due to lack of proper sewerage facilities. A period of thirty days was so voted by the Board.

The Board of Appeals has instructed Dartmouth Town Counsel to take action on the landing of this trailer after permission by denied by the Board of Appeals.

On 12/6/67, Mrs. Lydia Botelho, 69 Sharpe St., S.D. came to the office to complain in behalf of Mr. and Mrs. Manuel Botelho, 127 Sharp St., S.D.

There is a swamp on Fern Street owned by Joseph Martin. This area of land is being filled in from the street back and this is pushing the water onto the Botelho property. In the winter the water gathers in front of the Botelho home and freezes over creating a hazardous condition. Much of this water remains stagnant.

On 12/6/67 Mr. E.M. Huckins investigated this complaint. There was a mess of junk, rubbish, rats, and stagnant water. The cesspool on the Botelho property is flooded and the lawn mowers are under water. It appears this is a Board of Health problem.

It was a majority vote of the Board to have the Botelho's and Joseph Martin present at the next meeting.

Dr. J.G. McBratney reported Mr. Manuel Vargas has cleaned up his property and sink drain has been connected to the septic tank. Data to be filed.

Attached is a letter from the Department of Public Health, determination of maximum ground water elevation.

On 11/7/67 Mr. E.M. Huckins reported Mr. Joseph Downing, 34 Sable Ave., N.D. had his system and open trench pumped out on Monday 11/6/67.

His installer, Joseph Fortes, had promised to come on Tuesday to complete the repair job but did not show up.

On Friday Mr. Fortes dug down nine feet and found sandy material.

As per inspection 11/13/67 there was one load of dirty fill which is not acceptable. Mr. Downing said this had come from David Brasells pit.

Mr. Fortes said David uses this material for his sytem and if he can so can Mr. Downing use it. David went to the Downing property and found Mr. Downing was given the wrong type of dirt. David has agreed to bring in good grandular fill. The stone in the trench must be washed.

It was agreed by the Board to watch this system installed on a day to day basis.

Mr. Fortes said he would take samples of the dirt to Boston office (D.P.H.) for an analysis.

On 11/6/67 Mr. Joseph F. Martin, 152 Sharp St., S.D. called the office to report Dorothy Winderlick, 15 Fern St., S.D. is dumping garbage on his land across the street from the Winderlick dwelling.

The land across the street is not owned by Mr. Martin. The owner is Manuel Santos Andrade, 115 Willis St., S.D. This information was obtained from the office of the Board of Assessors.

On 11/8/67 I, Dolores Piva, called Mrs. Winderlick on this complaint. She said she deposits her rubbish across the street on the Andrade property and with the owners permission. All the rubbish is thrown into a hole and covered with fill to prevent a nuisance. There is no garbage thrown at any time.

Complaint filed.

It was a unanimous vote of the Board to renew the chicken permit to Frank Newman, 23 Hillcrest St., N.D. and also include 3 pair pigeons.

Sanitary Code, etc. as requested earlier in the year on all legislative action pertaining to Board of Health.

on 9/15/67, Mrs. Dorothy Winderlick, 15 Fern St. called to report that Colonial Black Top, Matthew Street is dumping old lumber, etc. at the end of Fern Street. This property owned by J.F.Martin, 152 Sharp Street. This debris will invite rats in the area. Mr. Martin was told by phone that only clean fill is allowed in the area of land. There are many tree stumps and large stones now being dumped on the property. Mr. Edward Medeiros is also dumping on the Martin property. The Board requested that a letter go to J.F.Martin, with carbon copies to Colonial Black Top and Edward Medeiros that there will be no dumping of stumps and debris but only clean fill.

The cleaning of all debris within 7 days from an open dump, property of Grinnell Assoc., in the rear of Shoe Horn, State Road, N.D., expired 9/15/67. Mr. Menard delivered two "no dumping" signs to Mr. Rogers and this area will be rechecked.

Mr. Huckins and Mr. Menard inspected Brito's Slaughter House and made a report as attached to these minutes. The Board agreed that the Sanitary Inspectors contact Mr. Roberts of the Massachusetts Food and Drug Department on some questions they would like answered.

On 3/20/68, Mrs. Andrew Conn, 24 Rockhill Drive, N.D. called this office that since the sewerage system had been pumped out, there has been no odor in her house. This includes the recent heavy rain period. She is very happy and also sorry that she took up so much of our time. Mrs. Conn also reported that the trenching done by the D.P.W. in the rear of homes on Idlewood Drive, N.D. has been very effective in relieving the water situation in the area.

On 3/25/68, a plumbing permit was issued to Albert Silva to correct the plumbing violations at the home of William Miller, 95 Chase Road, N.D. Therefore, there is no need to send a letter to Town Counsel as previously decided.

Mrs. Bertram Hastings, 23 Elm View Avenue, N.D. came to this office on 3/20/68 to complain that the area, ingeneral, from 23 Elm View Avenue and down, is all water logged from piles of dirt. The meeting came to order at 7:05 p.m. with all members present.

All bills approved and signed.

Mr. Bromley reported that he had investigated the request of Raymond Rogers, 101 Potter Street, S.D. for permission to stable one horse. He had adequate shelter and the required distance from dwelling and abutting properties. Mr. Bromley recommended and the Board voted to grant the request.

Mrs. Phyllis D. Mercer, Community Nurse, attended the funeral of her nephew on Monday 9/8/69. She inquired if she was to be paid and was told it would discussed with the Board. Mrs. Piva, clerk, called Isaac Manchester, Jr. of the Personnel Board, informed of the request and advised him that Mrs. Mercer is continued parttime employee and would this make a difference. Mr. Manchester stated that bereavement leave is clearly specified under Personnel Board rules and regulations but the Board could make their own decision on the payment. Mrs. Piva discussed this matter with the Board on 9/15/69 at her meeting but the full Board was not present so it was to be discussed at the meeting of 9/22/69. This payment is for three hours only. After it was discussed, the Board unamimously agreed to pay her for the three hours this time but should there be another time, it will have to be made up in time.

Mrs. Raphael said she would see if she could get a neighbor in the area to watch and see who is doing the dumping.

The Nimitz Street plan for Castle Homes, Inc., Lot #95 and part of #94 was briefly discussed. The elevation will be 5" higher than John Brooks' property which abuts it in the rear. Mr. Harrop and Mr. Bromley wanted to know why this is being built up higher that the Brooks dwelling. They requested Mr. Huckins ask Mr. Medeiros and Mr. Spohr individually this question. If there is no cooperation by Mr. Moniz, relay information to Town Counsel. Also inform Mr. Moniz the Board of Health could revoke his horse permit.

Mr. Ernest Coite, 80 Holland St., S.D. came to the office to complain of rubbish and garbage being thrown on Moss Street into swamp and slowing up the flow of water in brook which causes backing up of the brook near his house.

The area indicated is across from the two family house owned by Mr.

Manuel and Rosa DeMello on the corner of Moss and Wordell Streets, S.D.

I found that the brook was flowing without much interruption but considerable debris on its banks which might obstruct at a time of flood water flow.

The debris consisted of cans, bottles, rags, papers, mattress, stuffed furniture, bicycle, tires, wire and auto parts.

There were five unregistered cars around the DeMello property and another car which has been completely disasembled. There were three men repairing a car on Moss Street who moved the car onto Holland Street and continued to work on it. There were also three young men working on a motor bike which was being run back and forth across a field.

The DeMello cesspool was also running over onto Wordell Street.

Mr. Bromley reported that there was lumber and junk cars on Albro Avenue on the property of Edger Beaudoine and he would like the inspectors to check this complaint.

Mr. Harrop said he had posted "no dumping" signs near the Saratoga Club on Milton Street on the unaccepted section in response to a request by Manuel Botas, 188 Hemlock Street, New Bedford that individuals were depositing trash on his vacant lot.

The Nurse's monthly report for December was submitted to the Board and placed on file.

On 1/21/70, Mr. Milton Travers, 71 Florence Street, New Bedford who owns property at Box 102, Jordan Road where he has animals located and taken care of by a farmer living near by. Mr. Travers said he was not aware of the necessity of a permit for animals and fowl. He stated he had 2 ponies, 10 geese, 12 bantams and assorted ducks. Two days later Mr. Travers came into the office and reported half of these fowl had been killed by dogs or some other animals. The Board requested Frank Vieira, Animal Inspector, check out the property for shelter and distances and report his recommendations to the Board.

Mr. Herbert Harrop inspected the trailer coach park of Marie Gervais, 79 Cross Road, North Dartmouth on January 25th and found everything in good order so license was granted on January 26, 1970.

A plan of land for Alfred and Doris Sands, Highland Avenue showing boundary lines was received in this office from the Planning Board.
